## **Churchwardens' Report**

### **Churchwarden's report January 2024-December 2024, for the APCM St.Mary the Virgin, Clifton, with The Good Shepherd, Newton.**

This past year has been a series of preparation for the up-coming Quinquennial, 2025, and of getting quotes for some of the major works required by both St.Mary's and The Good Shepherd.

PCC meetings at the Good Shepherd have been well attended, and decisions taken on various matters which relate to the management of the buildings. Thanks to David McLean who has taken up the position of Clerk of Works. Thanks also to David Smith, who despite retiring, has kept us aware of the areas of work which sometimes get overlooked when concentrating on the bigger jobs. We have ensured that the Asbestos in the Organ box will be safely removed as soon as possible. On our 'to-do' list for the upcoming year is the re-caulking of the windows, a new sound system, and, of course, the heating system; all of which will need planning for. The Fire Extinguishers have been serviced in both churches.

During the year we have held all the listed services, and have been so fortunate to have Rev. Pete, Rev. Ian, and, after his Ordination, Rev. Adrian to officiate at each service. We are also indebted to Dr.Peter Kent, who has led many of the Services of the Word up at Newton. All our services have been supported by our band of Volunteers, who have been sidespersons, Readers, Servers, and Intercessors; we are blessed to have people who open our churches in the mornings and close them in the evenings, making sure there is nothing amiss. Thank you to all who play a part in the running and upkeep of both St.Mary's and The Good Shepherd, including the cleaners, the flower arrangers and the bell ringers, who call the faithful to worship each Sunday morning. During this year, we have celebrated our oldest Bell in the tower, which is 400years old. We opened up a competition at school to name the bell, from a list of 'suitable' names, and the top vote was – St. Agatha. St. Agatha was the patron saint of Bell Founders, so very appropriate. We will arrange a service to formally bless the bell, alongside the other bells which have been named by various organisations in the village. We held an open day to celebrate our 400yr old bell and this generated lots of interest, particularly by our younger ringers.

We held an Ashing Service at The Good Shepherd this year, and held a weekly Lent Study, with an average attendance of 10 people from the Benefice.

Lynn and Sue were re- dedicated as Churchwardens at the Archdeacon's Visitation which took place at Harbury on the 12th May.

Christ Church was formally consecrated as a Church of England on 16th May.

Rev. Adrian Thacker was Ordained on 30th June.

Rev.Pete led a Confirmation group in the Benefice and the Confirmation took place on November 23rd at Coventry Cathedral, with Acting Bishop Ruth celebrating.

We have held 2 weddings and 1 baptism during the year.

As a church we are very blessed to have been in receipt of some legacies, and these will be used to improve facilities and structures at both St.Mary's and The Good Shepherd, to keep them both in good order.

Thank you to our PCC who have been our guide during the year, and who have given their support to all of the decisions made; we are confident for the future, in that we are growing the church within the Benefice, and have some younger families joining us. We continue to work well with the school, and try to support their projects when we can.

The Churchwardens look forward to working on behalf of the churches for another year.

## Financial Report to December 31st, 2024

The PCC of St Mary's and The Good Shepherd Finance Report 2024

### Executive Summary

This report presents the financial performance and position of the Parish for the year ending 31 December 2024. Despite a mid-year treasurer transition and subsequent challenges in accessing accounts, which impaired treasury functions for approximately three months during the summer, the Parish maintained operational continuity. Total funds declined by £8,518 to £237,484, though this figure adjusts to a £3,734 increase when accounting for a significant post-year-end debtor. Projections for 2025 incorporate inflationary pressures, planned capital expenditure, and potential income from an inheritance, alongside strategic actions to optimize resources.

---

### Financial Position

#### Opening Position (1 January 2024)

At the beginning of 2024, the Parish held total funds of £246,002, comprising:

- CCLA Investment Account: £213,737 (interest-bearing).
- Lloyds Current Account: £32,048 (non-interest-bearing).

#### Closing Position (31 December 2024)

By year-end, total funds stood at £237,484, reflecting a net decrease of £8,518. The balances were:

- CCLA Investment Account: £225,082 (inclusive of reinvested income).
- Lloyds Current Account: £12,252.

The financial performance for 2024 included:

- Total Income: £50,453.
- Total Outgoings: £48,522.

Adjusting for a £12,402 debtor (a Town Lands Charity cheque received in January 2025 but owed in December 2024), the adjusted year-end total would be £249,736, representing a net increase of £3,734 over the opening balance.

### Income Analysis

Total income for 2024 amounted to £50,453, derived from two primary sources:

#### Lloyds Bank Deposits

- Planned Giving: £12,286.00
- Loose Collections: £3,373.00
- Weddings & Funerals: £827.00
- Donations: £4,390.00

- Irregular Income: £6,175.00
- Town Lands Charity: £12,402.00

**Total Lloyds Deposits: £39,708.00**

#### CCLA Investment Income

- Reinvested Income: £11,190 (full-year return at an average rate of approximately 4.75%).

#### Expenditure Analysis

Total outgoings for 2024 were £48,522, categorized into running costs (£15,854) and church activities (£32,668). Running costs increased by £1,814 (12.6%) compared to 2023, primarily driven by maintenance expenses at St Mary's.

#### Running Costs Breakdown

- St Mary's: Insurance:
  - £3,747.00
  - Utilities: £3,954.00
  - Maintenance: £4,629.00
- The Good Shepherd:
  - Insurance: £623.00
  - Utilities: £2,473.00
  - Maintenance: £428.00

**Total Running Costs: £15,854.00**

#### Church Activities

- Diocese Parish Share: £26,134 (bulk of activities expenditure).
- Other Activities: £6,534 (e.g., organ playing, miscellaneous expenses).

#### Restricted and Unrestricted Funds

The Parish manages several restricted funds, which include apportioned investment returns:

- Bell Fund: £2,846.
- North Wall Fund: £229.
- Newton Fund: £1,418 (established in 2024, restricted for Newton-specific use).

Total restricted funds: £4,493.

Unrestricted funds totalled £245,243, allocated as:

- Clifton Reordering Fund: £6,356.
- Newton Reordering Fund: £3,344.
- General Unrestricted Funds: £222,873.

## Financial Projections for 2025

### Economic Context

The UK Consumer Price Index (CPI) rose by 3.5% in 2024, exceeding the Bank of England's 2% target. Forecasts suggest a decline toward 2% in 2025; however, a prudent 3% inflation rate is assumed for planning purposes.

### Outgoings Forecast

- 2024 Base Outgoings: £48,522.
- Inflation Adjustment (3%): £1,456.
- Subtotal: £49,978.
- Capital Expenditure: £11,231 (new audio system installation).
- Total Projected Outgoings: £61,209.

Mitigating Factors: One utility contract is fixed for three years at a 15% reduction, and the treasurer aims to secure a similar rate for the remaining utility, potentially offsetting inflationary pressures.

### Income Forecast

- CCLA Investment Income: At 4.75%, the current £225,082 balance yields £10,691 annually. A potential £50,000 inheritance, if deposited, increases the total to £275,082, yielding £13,066.
- Lloyds Deposits: Applying a 3% inflationary increase to £39,708.

### Summary Projections

- Base Scenario (No Inheritance): Net increase of £843, resulting in c. £238,000.

## Inflation and Investment Dynamics

Interest rates reflect nominal economic growth (real growth plus inflation). The CCLA's 4.75% return currently exceeds the 3% inflation projection, but outgoings growth outpaces investment income at present asset levels. Lower inflation benefits the Parish by moderating cost increases more than it reduces returns. A tipping point exists where higher inflation becomes advantageous if CCLA holdings reach £400,000–£1,000,000 (depending on donation levels), at which point investment returns offset rising costs. Current CCLA assets (£225,082, or £275,082 with inheritance) remain below this threshold.

## Treasurer's Strategic Actions for 2025

1. Gift Aid Reclamation: Maximize recovery of Gift Aid for 2024 and prior years to enhance unrestricted funds.



2. VAT Reclamation: Pursue claims under the Listed Places of Worship Grant Scheme (LPWGS) for eligible maintenance costs at St Mary's and The Good Shepherd. The LPWGS, administered by the DCMS, expires on 31 March 2026.
3. Utility Cost Management: Secure favourable fixed-rate contracts for remaining utilities to mitigate energy price volatility.

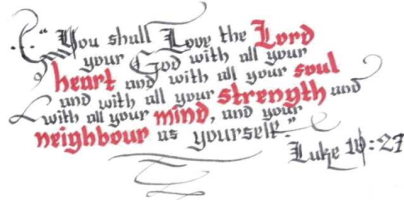

## School Report

### School report

*With open minds and loving hearts, we will achieve.*



During 2024, the relationship that St Mary's church has with Clifton Upon Dunsmore Primary School has continued to develop with plenty of opportunities for interaction between church and school.

All the children come to church for whole school seasonal services as well as the classes in turn attending Collective Worship in church on Thursday mornings. Services have included Easter, Harvest Festival, Advent and a Carol Service led by children from Y5 and 6 in which the Belle Plates group performed. Some of the services have been led in school by Rev Pete such as the outdoor service on Remembrance Day and we were able to attend the Nativity performance that Reception stage annually, this year with Sue McKenzie narrating.

At the beginning of the year, some of the children in the choir were attending church on the third Sunday of the month to participate in the services. Unfortunately, although this was appreciated by the congregation, this has fizzled out. However, some children did participate in the church candlelit carol service which included a soloist starting the event.

This year the RE curriculum has changed. The RE teacher at Clifton school has been part of the development group so the transition has been smooth. It is now known as 'Religion and Worldviews'. The learning section of the school website has been updated, including the policy and curriculum statement. There are documents for parents to explain the curriculum and Understanding Christianity. It is well worth taking a look. <https://www.cliftonupondunsmoreprimaryschool.uk/RE/>

School holds RE days, usually once a term and it is a joy to go into school to see what the children are learning. Topics for the days have included how Easter and Christmas are celebrated around the world. On the day centred on 'Holy Words', Reception produced some artwork which was a winner in the national [NATRE Spirited Arts Competition](#).

There have been several opportunities for the foundation governors to attend diocese online training, mainly around SIAMS (Statutory Inspection of Anglican and Methodist Schools) monitoring and the new framework introduced after our last inspection but also the new curriculum. We will be supporting the school as they develop, implement and monitor a new Spirituality Policy. Sue was able to attend the annual Headteachers and Parish Partners conference. and the annual governors' conference.

A major change to school has been the introduction of a Pre-School in September which is going very well. The children attended the Remembrance Day Service, and although the intention had been for them to stay for a short while, they were so well behaved they remained until the end. They were also eager participants in the Reception Nativity.

Other visitors to the Remembrance Day service were some residents of the Elms. They also regularly attend the weekly hymn practice and look perfectly at home.

The school supports the Charity Asha which enables children in the slums to receive a good education. Each year some of the Clifton staff visit New Delhi, and we had a presentation from them in one of our Sunday services. A founder of the organisation visited school in the autumn term together with two ex-students who have now graduated and will be undertaking Masters degrees which would not have been possible without Asha. The girls visited each class in turn, explaining differences between their state school and Clifton and how Asha had helped them. They also contrasted their homes with those of the Clifton children. As governors we are always told to assess the impact of what the children are taught, and one of the girls in Y6 wrote about the Asha visit in the school newsletter, and invited parents to give to the charity, explaining that although times may be hard for us, they are harder in the slums. The Head Teacher will be visiting Asha again during February half term.

We also had the opportunity to attend the leavers service at the end of the school year and other end of year activities and it is wonderful to see how the children progress during their time at Clifton and how confident they become, ready to move on to the next stage of their lives.

Whenever we are with the children. we can observe that not only are they eloquent in talking about Christian values, but they also demonstrate them. On school visits, outsiders have observed how well the children behave and how knowledgeable they are. We can see that the ethos of the school is to encourage every child to achieve their full potential, whatever their capability. The staff work well as a team and support each other. It is a real privilege to be part of such a wonderful school.

## **Bell ringing report**

### **Bellringing report for the PCC (Jan 2024 to Dec 2024)**

2024 was a busy year for the bellringers at St. Marys.

In July 2024 we celebrated the Church's oldest bell, that was installed 400 years ago in 1624. We co-ordinated this with the church and other village groups on Saturday 13<sup>th</sup> July 2024. It was a very busy and enjoyable day and we took many visitors up the tower, most of whom made it all the way up to see the bells. The church asked the Clifton school children to name the oldest bell and the winning name was "St. Agatha" the patron saint of bell founders.

A number of people were very interested in learning to ring with us following this open day and two younger ringers, George and Alexis have been ringing with us regularly since then. We have also seen several other younger ringers interested in ringing over the past 12 months.

We held the district striking competition at Clifton on Saturday 16<sup>th</sup> March 2024. 12 teams entered from across the Coventry & Warwickshire area, and we placed a very respectable 4<sup>th</sup> place.

Some of our younger ringers were once again representing Coventry & Warwickshire and were selected to be in the "Coventry Spires" youth team. They entered the national youth ringing contest, held in London on Saturday 6<sup>th</sup> July 2024. They rang at several of the London churches including St Mary-le-Bow and enjoyed the day, and got to meet young ringers from across the country.

We currently have 6 adults and 5 junior ringers at St Marys. The adult ringers are currently progressing with the on-line safeguarding training that is required. Most adults also have the required DBS checks in place.

On Saturday 11<sup>th</sup> January 2025 we were asked to host an open ringing event for the Coventry guild and a number of ringers from around the area came to Clifton. There was general ringing followed by a pub lunch and quiz over at the Bull pub.

There are already a number of events planned for the year ahead,

- Looking to continue the remedial works planned for the bells and we will approach Taylors at Loughborough for a revised quote and advise the church what these costs will be
- Ringing to commemorate the 80<sup>th</sup> anniversary of VE day on 8<sup>th</sup> May 2025
- Hosting the Rugby District Annual Meeting on Saturday 14<sup>th</sup> Feb 2026

We continue to ring the bells at St Mary's from 9am on Sunday mornings for half an hour before regular Sunday services. Our practice night is on Wednesday evening, with those learning to ring arriving at 7pm with the main practice starting around 7.30pm and continuing until 9pm.

We also ring at other times as requested, for weddings, funerals or other special occasions. We try to advise the village community via the village Facebook page when the bells might be rung at different times.

## **Independent Examiner's Report to the PCC of St. Mary's Church, Clifton-upon-Dunsmore and The Church of the Good Shepherd, Newton**

This Report on the financial statements of the PCC for the year ended 31st December 2024, which are set out on pages 1 to 4, is in respect of an examination carried out in accordance with the Church Accounting Regulations 2006 ("the Regulations") and Section 132 of the Charities 2011 ("the Act").

### **Respective responsibilities of the PCC and the Examiner**

As members of the PCC you are responsible for the preparation of the financial statements; you consider that the audit requirements of the Regulations and Section 144(2) of the Act do not apply.
